### 2) Sahara Midcap Fund: Introduction of new Benchmark Index S & P CNX 500 w.e.f 1/8/2005.

CNX Midcap 200 Index was discontinued by NSE w.e.f 18/7/2005. A new Index CNX Midcap was introduced by NSE w.e.f.18/7/2005. The new index had an upward adjustment of 3.86%.
