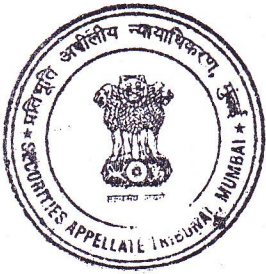

1. Since the orders impugned in these two appeals are passed without going into the merits of case, we direct One Life Capital Advisors Ltd. to make a fresh application on or before May 10, 2018 seeking approval of SEBI for being the sponsor by purchasing 100% equity capital of Sahara Asset Management Company Pvt. Ltd. If such an application is made on or

before May 10, 2018 SEBI shall consider the said application on merits and in accordance with law.

2. If the application is made on or before May 10, 2018, then, till the decision on said application is communicated to the appellants and one week thereafter, SEBI shall not enforce the orders impugned in these two appeals.


3. Both the appeals are disposed of in the aforesaid terms with no order as to costs.


